
Scurlock Lands West of Pittsboro (6/30/22)

Narrative

Scurlock family holdings in the area west of Pittsboro included a 120-acre tract purchased by George Scurlock and Simon Scurlock Jr. in 1879; much of this land remains in family ownership. There are no references to houses or graves in the deed history, although Tax Parcel 6001 has a house on it. An examination of wills, probate files, and family papers is needed to fully describe the history of this land.
